

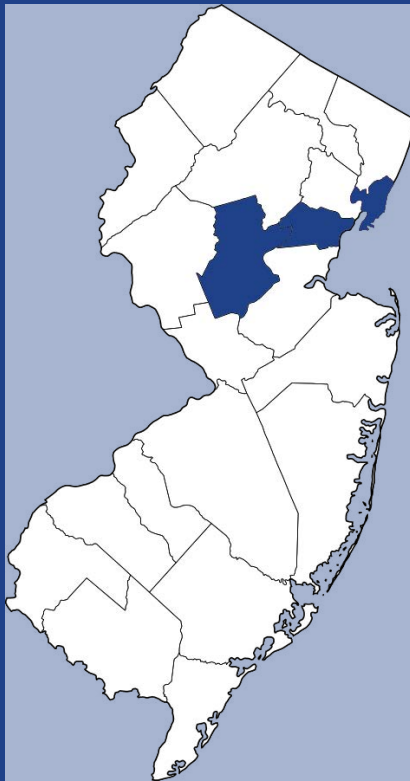

## GEOGRAPHY & GOVERNANCE

### *Geographic Boundaries of Service Area*

Somerset County is a 305 square mile county with 330,604 residents that is located in north-central New Jersey. The County's geographic boundaries include Morris County to the north, Hunterdon County to the west, Mercer County to the south, Middlesex County to the southeast, and Union County to the east. Out of New Jersey's 21 counties, Somerset is the 13th largest by both population and land area.

There are 21 municipalities that comprise Somerset County ranging in size from 400 to 62,000 residents. Of the 21 municipalities, eight have a combined 45 "sub-communities," or Census Designated Places (CDPs), historical areas, unincorporated areas, and enclaves that exist within their boundaries. When added to the total number of municipalities without sub-communities, there are 58 total communities in Somerset County.



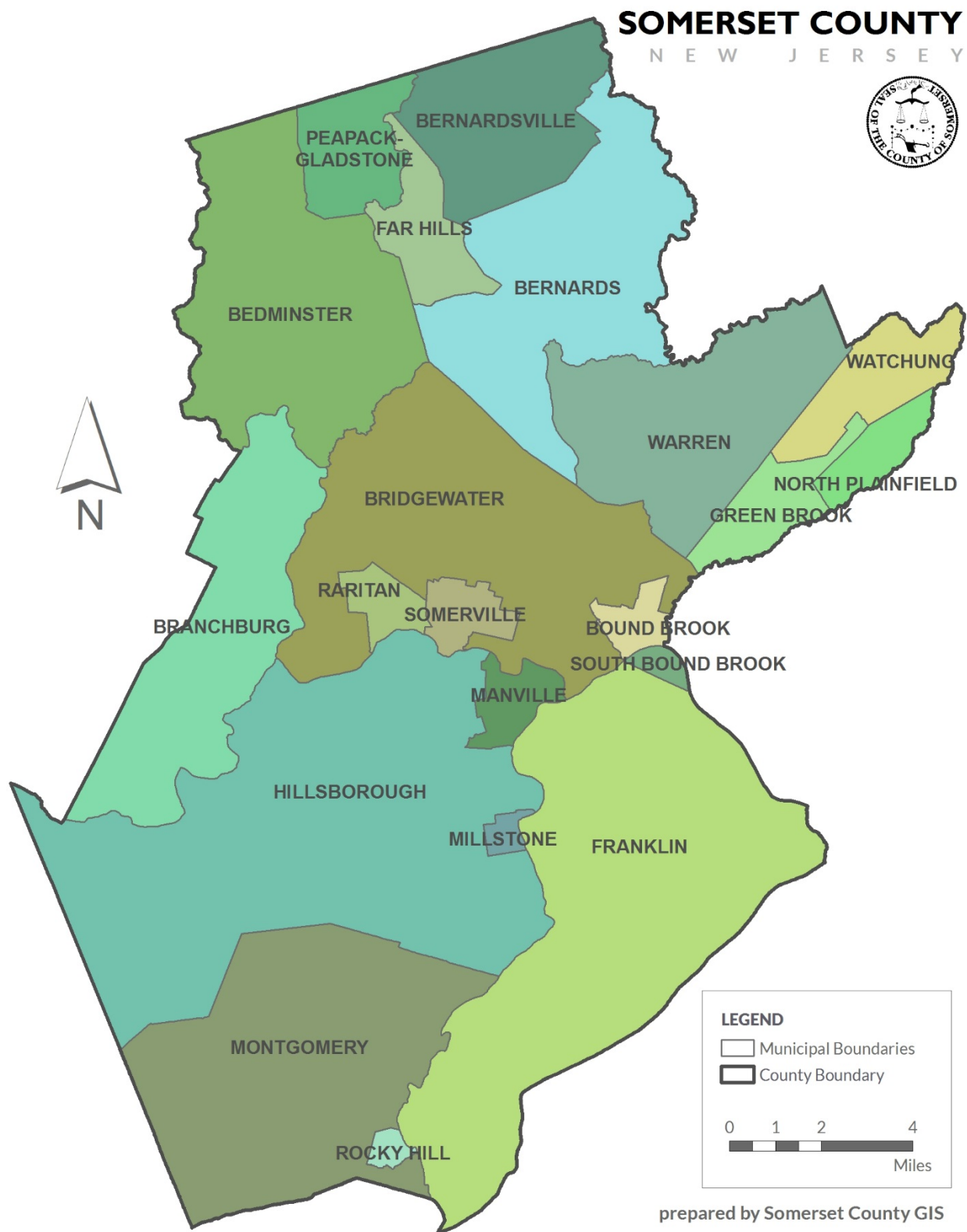

Although common in southern New Jersey, the concentration of non-municipal communities in Somerset County far outpaces other northern counties. This is an important distinction as sub-communities of a larger municipal unit can (and oftentimes do) have very different ethnic, linguistic, socioeconomic, cultural, and other characteristics than other sub-communities within that unit or the municipal unit as a whole. Also, some communities comprise a large percentage of Somerset County's land area, and the needs of populations within those municipalities can vary greatly from border to border.

### *Governing Structure*

Somerset County is governed by a five-member Board of Chosen Freeholders, whose members are elected at-large (i.e. county-wide) to three-year terms of office. Other constitutional officers elected on a county-wide basis include the County Clerk, Sheriff, and Surrogate. Somerset County is part of Vicinage 13 of the New Jersey Superior Court (along with Hunterdon County and Warren County), which is seated at the Somerset County Courthouse in Somerville. The Freeholders employ a full-time County Administrator who manages the day-to-day operations of county government. Department heads are appointed by resolution of the Board. Somerset County has approximately 1,110 full-time and 130 part-time employees in 52 divisions, including a library system.

The 7th and 12th Congressional Districts cover the entirety of Somerset County. Additionally, Somerset County is part of the 16th, 17th, 21st, 22nd, 23rd, and 25th New Jersey Legislative Districts. Although one of New Jersey's most reliably conservative-voting counties, registered members of the Democratic Party outnumber registered members of the Republican Party, with unaffiliated registered voters outnumbering both parties by a 2 to 1 margin.

## DEMOGRAPHICS

### *Population and Related Trends*

As of the release of the 2011-2015 American Community Survey 5-Year Estimates, the population of Somerset County is estimated at 330,604 residents. This represents an influx of 33,114 residents, or a more than 11% increase in population, since the 2000 United States Census.

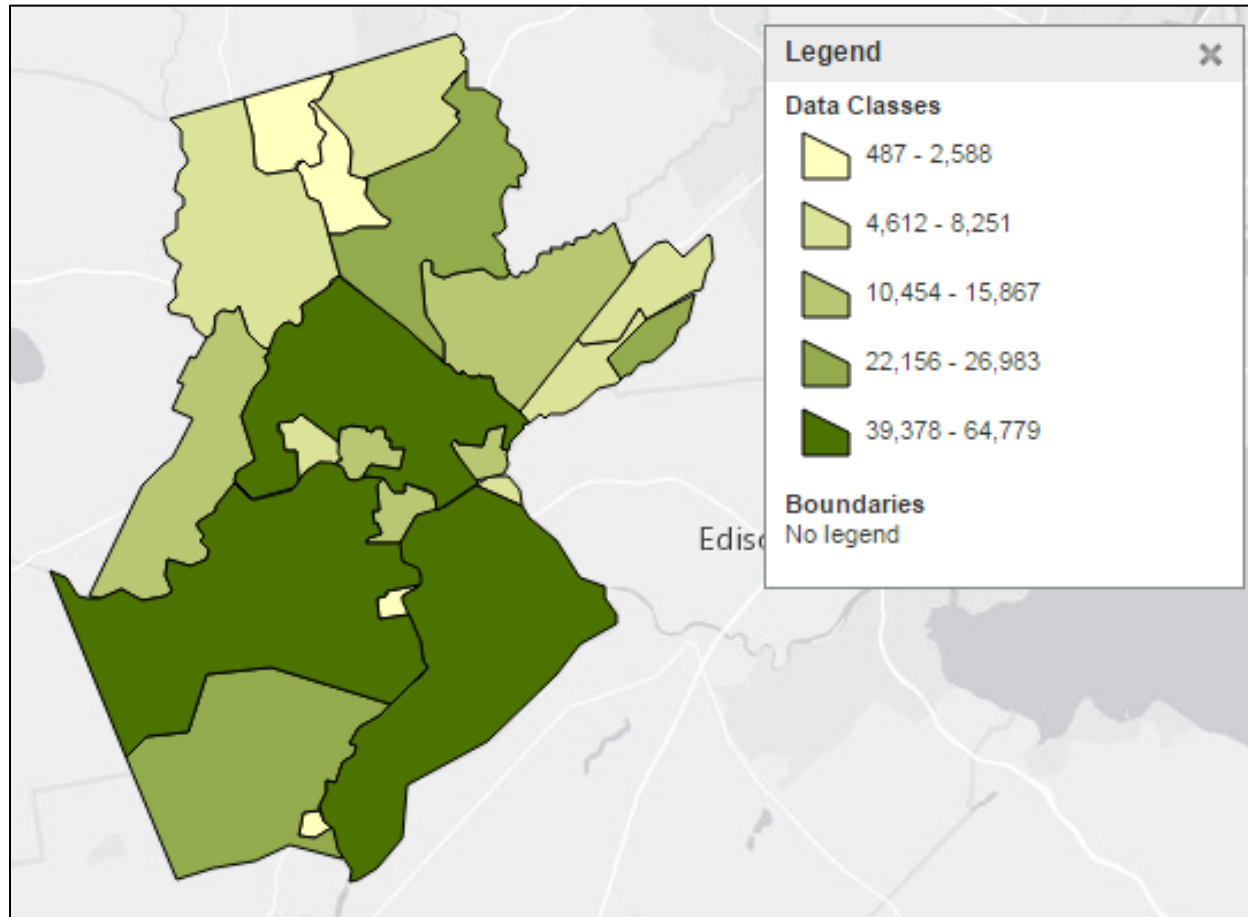

The largest municipalities in Somerset County, among those with more than 25,000 residents, are Franklin Township (64,779), Bridgewater (45,120), Hillsborough (39,278) and Bernards (26,983). The fastest growing towns in Somerset County are Franklin Township and Montgomery (see Table 3). Three towns experienced negative growth between 2000 and 2015: Bedminster, Somerville, and Rocky Hill.

### *Racial and Ethnic Composition*

The resident population of Somerset County is 59.4% White/Non-Hispanic, 16% Asian, 13.9% Hispanic/Latino, 8.8% Black/African-American, and 1.9% Other/Mixed Race. The most predominant countries origin among the Asian population include India (51%), China (26%) and the Philippines (10%). The most predominant countries/territories of origin among the Hispanic/Latino population are Puerto Rico (19%), Ecuador (13%), Mexico (12%) and Colombia (11%). Among the Hispanic/Latino population, 42% are from North America, 36% are from South America, 18% are from Central America, and 4% are from Europe.

### Minority Communities

Among Somerset County's 21 municipalities, there are four that are predominantly minority communities: Bound Brook, Franklin, North Plainfield and South Bound Brook. The communities with the highest percentage and total population of Hispanic/Latino and Black/African-American residents are Franklin and North Plainfield. Bound Brook also has a high percentage of Hispanic/Latino residents. The communities with the highest percentage and total population of Asian residents are Montgomery, Franklin, Green Brook and Bridgewater.

### Changes in Ethnic Composition

The racial and ethnic composition of Somerset County has changed drastically over the past 15 years. The percent of the population that is comprised of White/Non-Hispanic residents decreased in every single municipality in the County, with only two communities (Millstone and Far Hills) reporting an increase in the number of White/Non-Hispanic residents. According to an analysis of demographic changes between the 2000 US Census and the 2015 American Community Survey, the municipalities with the most rapidly changing racial and ethnic composition are Far Hills, Green Brook, and Manville. Far Hills measured among the top five of all municipalities in terms of both percent of population increase and total population increase comprised of Hispanic/Latino, Black/African-American, and Asian residents, the only community in the County to rank in the top five of all six categories.

## Gender and Ages

Of the 330,604 residents of Somerset County, 161,252 are male and 169,352 are female. Males (48.8%) and females (51.2%) comprise the same percent of the population today as they did at the time of the 2000 Census. Communities with the highest percentage of young children (under 5 years) include Bound Brook, Franklin, Hillsborough, Millstone, North Plainfield, Somerville, South Bound Brook and Watchung.

### *Dependency Ratio*

The table below summarizes the median age and dependency ratios for each community in Somerset County. According to the United States Census Bureau, one way to analyze “age distributions is the dependency ratio, or the ratio of the dependent-age population (young or old) to the working age population. The higher this ratio is, the greater the burden of support on working people in specific geographic areas.” The youngest communities in the County include Bound Brook, Somerville, North Plainfield, and South Bound Brook. Communities with the highest child dependency ratios include Millstone, Montgomery, Bernards, Warren and Peapack-Gladstone. Communities with the highest old-age dependency ratio include Rocky Hill, Watchung, Green Brook, Bedminster and Warren.

*Household Composition*

There are 115,998 households in Somerset County, 73.25% of which are family households. Additionally, 35.04% of households are comprised of families with children. Of families with children, 82.7% are married couples, 14.2% are single mothers, and 3.1% are single fathers. The average household size is 2.81 and the average family size is 3.34.

*Households with Children*

The communities with the highest percentage of family households with children include Montgomery, Peapack-Gladstone, Warren, Bridgewater and Bernards and the communities with the highest percentage of married couple households with children include Montgomery, Warren, Bernardsville, Hillsborough and Bridgewater. The communities with the highest percentage of single fathers include Peapack-Gladstone, Far Hills, Green Brook, Bound Brook and North Plainfield. The communities with the highest percentage of single mothers include North Plainfield, Peapack-Gladstone, Manville, and Bound Brook, closely followed by South Bound Brook, Franklin and Somerville.

# **ECONOMICS & POVERTY**

## *Economic Activities*

Somerset County is one of the top 10 most affluent counties in the United States. The median household income is \$100,667 and the per capita income is \$48,791, both of which are nearly twice the national average. However, there are communities within the county that struggle across a range of economic indicators. Communities such as Bound Brook, Manville, North Plainfield, Franklin, Somerville, and South Bound Brook have lower median household and per capita incomes and have higher rates of households receiving Supplemental Security Income (SSI), cash public assistance and SNAP benefits. Communities with the highest rate of uninsured residents include Bound Brooks, North Plainfield, Manville, Raritan, Somerville and South Bound Brook.

### *Number Below Poverty Level*

The poverty rate in Somerset County is 5% for all people, 3.6% for all families, and 6% for all children. At 13.6%, the poverty rate for single mothers is 7.5 times the poverty rate for married couple families. More than two-thirds of Early Head Start and Head Start eligible infants, toddlers and preschoolers are within five communities, totaling 870 children, or more than four times Head Start-funded enrollment: Franklin, North Plainfield, Bound Brook, Manville and Somerville.

## Education

There are 17 public school districts in Somerset County and 11 public high schools. The county-wide graduation rate is 92.5%, slightly higher than the statewide adjusted cohort graduation rate of 90.5%. There are three high schools with a graduation rate lower than the state and county averages: Bound Brook (77%), Franklin (86%), and Somerville (89%).

The countywide dropout rate is 0.7%. Three school districts have a dropout rate higher than the state average: Bound Brook (2.9%), Franklin (1.2%), and Manville (1.5%). In terms of total students who dropped out during the 2015-2016 school year, the top five districts were Franklin (33), Bound Brook (17), Somerville (9), Hillsborough (9) and North Plainfield (8).

Communities with the highest percentage of economically disadvantaged students, defined as those eligible for free and reduced price lunch, include Franklin, North Plainfield, Somerville and South Bound Brook. The county-wide rate of economically disadvantaged students is 21.8%.

The county-wide rate of students with a disability is 14.6%. Most districts have a rate of students with disability that is relatively consistent with the county-wide average.

The county-wide rate of English Language Learners is about 4%. Districts with the highest percentage of English Language Learners include Bound Brook, Franklin, and North Plainfield. The most common non-English language that is the primary language spoken at home is Spanish, followed by Chinese.

### *Literacy Levels*

The table below shows the percentage of students who met or exceeded expectations on standardized assessments of English Language Arts Literacy for each school district in Somerset County. Sample scores were collected from three grade levels spanning elementary, intermediate and high school: 3rd, 8th, and 11th. The school districts with the lowest average literacy rate include Bound Brook, North Plainfield, Franklin, and Somerville. All four of these districts rank in the bottom six, in different variations, of districts in Somerset County in terms of functional literacy.

### *Adult Educational Attainment*

In Somerset County, 5.9% of adults over 25 do not have a high school diploma, and 27.8% have a high school diploma, equivalency, or less. More than half, or 52.5% of residents, have a Bachelor's Degree or higher. Communities with the lowest rates of adult educational attainment include North Plainfield, Bound Brook, Manville, Green Brook and Somerville. These communities have the largest percentage of adult residents without a high school diploma and the highest percentage of adult residents who did complete a college degree.

# HEALTH

## *Insurance Coverage*

Approximately 8% of Somerset County residents do not have health insurance, including 3.34% of children, 3.68% of children under 6, 11.05% of adults, 1.94% of seniors, and 25.95% of individuals below poverty. The communities of Bound Brook, North Plainfield, South Bound Brook, Manville and Somerville have the highest rates of uninsured, particularly for total uninsured and adults uninsured. The communities of Bound Brook, Manville, Far Hills and Watchung have the highest rates of children without health insurance coverage.

### *Prevalent Health Problems*

- Lead: According to the New Jersey Department of Health for Somerset County, 1.36% of children ages 6-26 months, 1.15% of children under 6 years of age, and 1.44% of children under 17 years of age have an Elevated Blood Lead Level (equal to or above 5 micrograms per deciliter). This is the third lowest rate in the state and less than half the statewide average for all age ranges.
- Diabetes: According to the Robert Wood Johnson Foundation's County Health Rankings and Roadmaps, approximately 9% of adults over the age of 20 years old have diabetes, which is the fifth lowest rate in the state and below the statewide average.
- HIV: The HIV prevalence rate in Somerset County is 225 per 100,000 residents, the sixth lowest rate in the state. There are approximately 617 HIV diagnoses in Somerset County.
- Mortality: The premature age-adjusted mortality rate in Somerset County is 210 per 100,000 residents, the third lowest rate in the state.
- Sexually Transmitted Infection: The rate of sexually transmitted infection in Somerset County is 173 per 100,000 residents, the sixth lowest rate in New Jersey.
- Clinical Care: In Somerset County, the ratio of primary care providers to residents is 926:1 (4th in state); the ratio of dental care providers to residents is 1,112:1 (5th in state); and, the ratio of mental health care providers to residents is 406:1 (3rd in the state).
- Preventable Hospital Stays: Somerset County has over 35,000 Medicare enrollees. The rate of preventable hospital stays among Medicare beneficiaries in Somerset County is 42 per 100,000, the lowest rate in the state.
- Mammography Screening: Approximately 65% of Medicare enrollees received a mammography screening in Somerset County, the second highest rate in the state.

### *Communicable Diseases*

According to the New Jersey State Health Assessment Data, there were 798 reported cases of communicable disease in Somerset County in 2015. The most common cases reported were Lyme Disease (258), Hepatitis C – Chronis (141), Campylobacteriosis (89), Influenza Type A (84), and Salmonella – Non-Typhoid (38). The average county in New Jersey reported 1,226 cases of communicable disease in 2015.

### *Hospitals and Health Clinics*

There is one hospital in Somerset County, Robert Wood Johnson University Hospital, located in Somerville, New Jersey. There is one Federally Qualified Health Center (FQHC), also located in Somerville, New Jersey. FQHC's play a vital role in providing health care services to low-income populations, as they accept patients irrespective of their ability to pay. Further, parts of Somerset County are up to 20 miles away from either facility. For families without or with limited access to a vehicle, traveling to and from these medical facilities is extremely difficult.

### *Foster Care*

According to the New Jersey Child Welfare Data Hub, there are currently 151 out-of-home foster care placements in Somerset County. The placement rate is 2.3 per 1,000 children.

### *Incidence of Child Abuse and Neglect*

In Somerset County, there were approximately 2,190 cases of child abuse and neglect reported to the New Jersey Department of Children and Families in 2015. In about 7% of those cases, the investigator determined that the reported abuse/neglect was substantiated or established, meaning abuse or neglect did occur. This totaled 153 youth in 2015.

### *Drug and Alcohol Abuse*

During calendar year 2015 there were 1,397 unduplicated substance abuse treatment admissions from Somerset County and 1,862 total admissions. Male admissions, accounting for 69% of all admissions, more than doubled the percentage of female admission (31%). Of all admissions, 44% were for alcohol, 31% were for heroin, 12% were for marijuana, and 13% were for other opiates, cocaine or other drugs. Of all referrals, 28% were self-referrals, 25% were from criminal justice sources, and 20% were from the intoxicated driver resource center. A total of 43% of admissions had no health insurance and 36% had Medicaid or Medicare. Also, 75% of admissions were of individuals with incomes below poverty, 53% were unemployed or not in the labor force, and 64 individuals were homeless.

### *Number of Children Born to Addicted Mothers*

According to New Jersey State Health Assessment Data, there were 13 women who gave birth in Somerset County between 2011 and 2013 that reported tobacco, alcohol or drug use during the term of their pregnancy.

### *Infant and Child Death Rates*

According to the Robert Wood Johnson Foundation's County Health Rankings and Roadmap, the infant mortality rate in Somerset County is 3 in 1,000 live births, which is the lowest rate of any county in New Jersey. The County Health Rankings and Roadmap also calculates the child mortality rate at 20 in 100,000 children, which is also the lowest rate in New Jersey.

### *Low Birth Weight*

According to New Jersey State Health Assessment Data, 7.6% of babies born in Somerset County are born with a low-birth weight, defined as less than 2,500 grams. This below the statewide average of 7.9% of babies born with a low-birth weight. Communities with the highest percentage of babies born with low birth weight include Watchung, Bedminster, Green Brook and Montgomery. Communities with the highest number of babies born with low birth weight include Franklin, Bridgewater, Hillsborough and North Plainfield.

### *Prenatal Care*

According to New Jersey State Health Assessment Data, 88.8% of pregnant women received early prenatal care, defined as receiving prenatal care during the first trimester. About 1% of pregnant women, or 32 total women, did not receive prenatal care at any point of their pregnancy. Communities with the lowest percentage of pregnant women receiving early prenatal care include North Plainfield (77.2%), Bound Brook (78.9%), and Somerville (79.6%).

### *Teen Pregnancy*

The teen pregnancy rate is defined as the rate of births over the past 12 months per 1,000 women ages 15 to 19. The teen pregnancy rate in Somerset County is 7 per 1,000 women, totaling 76 births. Communities with teen births in Somerset County include Bound Brook (17 births, or 53 per 1,000 teenaged women), Hillsborough (35 births, or 24 per 1,000 teenaged women), and South Bound Brook (24 births, or 115 per 1,000 teenaged women). No other town in Somerset County reported a teen birth over the past 12 months.

### *Immunization Levels Among School Children*

According to the New Jersey Department of Health, the immunization rate for all Pre-K to 12th grade students in Somerset County is 95.7%, including 96.7% of public school students and 94.2% of non-public school students. All three rates are higher than the statewide average.

### *Air and Water Quality*

According to the Robert Wood Johnson Foundation's County Health Rankings and Roadmap, "Particulate Matter is the average daily density of fine particulate matter in micrograms per cubic meter (PM2.5) in a county. Fine particulate matter is defined as particles of air pollutants with an aerodynamic diameter less than 2.5 micrometers. These particles can be directly emitted from sources such as forest fires, or they can form when gases emitted from power plants, industries and automobiles react in the air. The relationship between elevated air pollution, particularly fine particulate matter and ozone, and compromised health has been well documented. Negative consequences of ambient air pollution include decreased lung function, chronic bronchitis, asthma, and other adverse pulmonary effects." The average daily density of fine particulate matter in Somerset County is 11.3 micrograms per cubic meter, which is equivalent to the statewide average.

The United States Environmental Protection Agency operates the Safe Drinking Water Information System (SDWIS), which contains information about public water systems and their violations of EPA's drinking water regulations, as reported to EPA by the states. These regulations establish maximum contaminant levels, treatment techniques, and monitoring and reporting requirements to ensure that water systems provide safe water to their customers. Somerset County is one of six counties in New Jersey that does not have a health-related drinking water violation.

## *Children with Disabilities*

### *Number of Children with Disabilities*

There are 2,073 children with a disability in Somerset County, or 2.67% of all children. Communities with the highest childhood disability rate include Manville, Montgomery, Bridgewater, Branchburg and Rocky Hill. Communities with the highest disability rate for children under 5 years of age include Bernardsville, Bedminster, Branchburg, Manville, Franklin, and North Plainfield. No other Somerset County municipality reported children with disabilities under the age of 5 years old.

Somerset County has the third lowest violent crime rate per 1,000 residents and fourth lowest crime rate per 1,000 residents among 21 counties in New Jersey. Communities with the highest crime rate and violent crime rate include Bound Brook, North Plainfield, Somerville, Watchung, Manville, Raritan and Franklin. Communities with the highest overall incident of violent crime include Franklin, North Plainfield, Somerville, Bridgewater and Bound Brook.

### *Gang Membership*

In Somerset County, there are 60 gangs, accounting for 4% of all gangs in New Jersey. In Franklin, there are 12 blood sets and more than 20 gangs in total. North Plainfield identified the MS-13 gang as the most serious gang problem in three consecutive surveys, the only New Jersey municipality to do so.

### *Reports of Domestic Violence*

### *Children Receiving Free and Reduced Lunch*

More than 7,800 K-12 public school students in Somerset County receive free lunch, or 14.95% of all students. Districts with the highest percentage of free lunch participation include Bound Brook, North Plainfield, Franklin, South Bound Brook and Manville.

### *WIC Participants*

There are approximately 2,256 women, infants and children who receive WIC benefits in Somerset County, including approximately 209 pregnant women and 145 post-partum women. There are two local agencies who administer the WIC program in Somerset County: the Visiting Nurse Association of Central Jersey (only Franklin Township) and NORWESCAP for all areas of Somerset County except for Franklin Township. There are 24 authorized WIC vendors in Somerset County, spanning 13 municipalities.

### *Nutrition*

Among 21 counties in New Jersey, Somerset County has the second highest food environment index rating 9.1 out of a possible 10. This is due to the fact that Somerset County has a comparatively low percentage of residents without access to healthy foods and low percentage of residents experiencing food insecurity.

### ***SNAP Participation***

In Somerset County, 3.18% of households receive SNAP benefits, along with 4.28% of households with children. Communities with the highest SNAP participation rates include Manville, North Plainfield, Somerville, Bound Brook and South Bound Brook. These communities have high rates of SNAP participation rates among all different types of households, including married couples with children, single fathers, and single mothers.

## HOUSING

There are 124,672 housing units in Somerset County, including 115,998 occupied housing units. The owner vacancy rate is 1.5% and the rental vacancy rate is 9.7%. Approximately 23.9% of housing units are renter occupied, with a median rent of \$1,411. Roughly 43% of renters are housing burdened, meaning they spend more than 30% of gross rent as a percentage of income. The communities with the highest rental vacancy rates include Somerville, Bernardsville, Bound Brook, Manville and Bridgewater. The communities with the highest percentage of renters include Bound Brook, North Plainfield, Somerville, South Bound Brook, Raritan and Manville. Understandably, Bound Brook, North Plainfield, Somerville, South Bound Brook, and Manville have the lowest median rent in the county; however, housing burdened renters are more prevalent in communities such as Watchung, Millstone, Warren, Bernardsville and Hillsborough.

## *Housing Conditions*

In Somerset County, 5.21% of households do not own a vehicle. Approximately 2.1% of occupied units are substandard (lacking adequate plumbing, kitchen or telephone facilities). Additionally, 10.95% of housing units were constructed prior to 1939 and about 40% of units pre-date 1970, which suggests that a significant number of housing units could contain lead-based paint, which was not banned from residential use until 1978. Communities with the lowest rate of vehicle ownership are Manville, Somerville, North Plainfield, Raritan, South Bound Brook and Bound Brook, all large renter communities with low median rental rates. Communities with the oldest housing stock, and thus the highest risk of lead based paint exposure, include Rocky Hill, Peapack-Gladstone, Millstone, North Plainfield, Bound Brook, and Manville.

## *HUD Housing*

There are currently 5,915 housing vouchers available to very low-income families, as well as the elderly and disabled, in Somerset County. There are more than 5,772 family households living in poverty in Somerset County, in addition to more than 10,000 senior citizens and 10,000 adults with disabilities.



### *Homeless Count*

Somerset County conducted its annual Point-In-Time Count of the Homeless in collaboration with Monarch Housing Associates on January 26, 2016. The following excerpts are taken verbatim from the report published online at [www.monarchhousing.org](http://www.monarchhousing.org). On the night of January 26, 2016 a total of 184 households, including 218 persons, were experiencing homelessness in Somerset County. A total of one household, with one person, was identified as chronically homeless and nine unsheltered homeless persons were counted. This is a decrease of 124 persons (36.3%) and 95 households (34.1%) from 2015. Somerset County had 2.4% of New Jersey's statewide homeless population in 2015. Of the 184 homeless households counted in Somerset County in 2016, 18 (9.8%) were families with at least one child under the age of 18 and one adult, 15 less (45.5%) than 2015. These families included 51 persons, including 30 children under age 18, and 21 adults.

## CHILDCARE NEEDS

While there are a number of childcare providers and child development programs operating throughout Somerset County, not all are accessible to low-income families. HOPES is the only provider of free childcare and education for infants, toddlers and preschoolers ages birth to five in Somerset County, offering services at two locations. All other providers are fee-based or voucher-based programs, which are not affordable to Head Start eligible families.

### *Percent of Working Parents*

The table below depicts the percentage of families with children where both parents work, or in the instance of single parent families, where the primary parent/caregiver is in the labor force. Communities with a higher percentage of parent(s) working have a greater need for childcare options. Communities with the highest labor force participation rate among married couples include Rocky Hill, Millstone, Green Brook, Hillsborough, and South Bound Brook. Communities with the highest labor force participation rate among single fathers include Green Brook, South Bound Brook, Bedminster, Bridgewater and North Plainfield. Communities with the highest labor force participation rate among single mothers include Millstone, Watchung, Green Brook, Bridgewater, and Far Hills.

# TRANSPORTATION

## Public Transportation Services

New Jersey Transit operates two commuter rail lines that travel through Somerset County: the Raritan Valley Line and the Gladstone Branch of the Morristown Line, the latter of which offers Midtown Direct service to New York Penn Station. There are a total of ten train stations in the county, two of which are accessible to individuals with disabilities (denoted by \* in the table below).

Commuter rail transportation from Somerset County to employment centers such as Newark and New York City is time consuming and can be cost-prohibitive for low-income families. The trip from Somerset County to Newark ranges from 50 to 70 minutes and the trip to New York City ranges from 75 to 100 minutes. The cost of round trip rail travel to and from Newark ranges from \$18 to \$24 and the cost of round trip rail travel to and from New York City ranges from \$28 to \$32. The annual cost of commuting for an individual from points in Somerset County to major employment centers such as Newark and New York City exceeds \$4,000 and could top \$7,000 from some points of origin.

There are six commuter bus lines serving Somerset County that are operated by New Jersey Transit. Bus routes are primarily oriented around the central part of the county, including the US Route 22, US Route 202 and Interstate 287 corridors. Bus fare to New York City is also a costly expense, with prices averaging over \$20 for round trip tickets.

The County of Somerset offers fee-based community transportation services to the general public through three systems comprising a total of eight transportation routes. SCOOT provides services in the central part of Somerset County, including Hillsborough, Manville, Somerville, Bridgewater and Bedminster. Each one-way ride costs \$2.00 and the route includes a stop at Somerville Train Station. DASH provides service between Bound Brook and the New Brunswick (Middlesex County), passing through the Somerset section of Franklin Township. Each one-way ride costs \$2.00 and the route includes stops at Bound Brook Train Station and New Brunswick Train Station. CAT provides access to Raritan Valley Community College in Branchburg. Each one-way ride costs \$2.00 and the route includes stops at Bound Brook Train Station and Somerville Train Station.



## **FINDINGS AND RECOMMENDATIONS**

### ***Concentration of Poverty:***

As a whole, Somerset County is one the most affluent places in the United States. However, unlike older, more densely populated communities in northern New Jersey, poverty in Somerset County is distributed throughout the county. In Union County, Hudson County, Essex County, Bergen County and Passaic County, poverty is highly concentrated in specific areas. Yet, some of the most affluent communities in Somerset County demonstrate high indicators of need. As a result many high-need families, such as single mothers/fathers, may not have readily available access to supportive services within the boundaries of their communities. Transportation barriers (i.e. limited mass transit, long travel times, low vehicle access) further complicate accessibility to services for many households in need. A proactive and mobile approach to delivering services in these areas would be highly beneficial to ensure low-income families have accessibility to resources that support self-sufficiency.

### ***Highest Need Communities:***

There is no single community of Somerset County that stands out as the highest need community in the region. However, the communities of Bound Brook, Manville, North Plainfield, Franklin, Somerville and South Bound Brook appear to consistently exhibit indicators of need across major categories explored in the community assessment. Other communities with significant needs include Green Brook, Hillsborough, Bridgewater and Raritan. Based on the research conducted to prepare the community assessment, there does not appear to be any one particular (non-governmental) entity that delivers services on a county-wide basis, despite the arguable need for a truly county-wide operation. Exploring ways to scale the delivery of services throughout county would help address existing service gaps.

### ***Co-Location of Services***

As a result of distributed, rather than concentrated poverty, Somerset County residents tend to access supportive services through a very fragmented system. For example, NORWESCAP, the Community Action Agency for Hunterdon, Sussex and Warren Counties, operates a WIC and LIHEAP office in the Bridgewater-Raritan area of Somerset County, despite their main offices being nearly 40 miles away and two counties over. There does not appear to be a “one stop shop” for social services, despite the multiple systems that families in need are typically required to navigate when seeking support. Centralizing and co-locating services in high traffic areas (community centers, commercial districts, libraries, etc.) and developing a center-based, one-stop blueprint for making connections to multiple systems would streamline service delivery to Somerset County families displaying the highest levels of need. The benefits to client families would far surpass the current system, which is highly decentralized, fragmented, and not serving the best interests of families in terms of ease of access.

### ***Supportive Housing***

As almost half of all Somerset County renters are housing burdened, access to affordable housing is a major need. The number of housing vouchers available is well below the demand, a large percentage of the housing stock predates 1970 and may contain lead-based paint, and affordable housing appears to only be available in low-income areas. The low-income families who are more likely to confront the issues

of housing burden, lead-based paint, and affordability, would benefit from support that helps them find and maintain permanent housing solutions. This may include, but not be limited to, supportive housing services such as housing search and lease assistance, tenant-landlord conflict resolution, weatherization, minor repair workshops, and lead remediation.

### *Childcare Accessibility*

There are limited affordable childcare options available to Somerset County families. Families with the highest needs for free or affordable childcare, such as single parents or low-income parents who both work, also face the most difficulty in locating childcare. Finding ways to expand the availability of and/or access to free or affordable childcare should be a high priority in serving the residents of Somerset County.

### *Community-Based Partnerships*

There are a number of organizations based in Somerset County that are potential partners in building a collaborative framework for centralizing services and expanding access to supportive services for families. These organizations include, but are not limited to, the County of Somerset, Somerset County Community Action, United Way of Northern New Jersey (based in Morris County, local offices in Bridgewater), Empower Somerset, Family Support Organization of Hunterdon, Somerset and Warren (based in Hunterdon County with no Somerset County offices), Family and Community Services of Somerset County, NORWESCAP, Interfaith Hospitality Network, and Harvest of Hope. Below is a list of the primary focus areas of each of the organizations (with respect to Somerset County services). It is also recommended to establish working relationships, collaborations, and partnerships with Somerset County's many faith-communities, including churches, temples, and mosques.

However, there are many residents who do not have readily accessible health care, access to affordable health coverage, or other knowledge or resources that support preventative health. It is vital to ensure these families are reached and supported to ensure Somerset County's tradition of health is experienced by all.
